## **BASIC PURPOSE:**

The **Regional Manager**, **Intl Trade Development - Tampa** is responsible for the promotion of exports with export-ready manufacturers and other companies through counseling, implementation of EFI export promotion programs and a synergy of promotional programs with other economic development and strategic alliance partners.

### **ESSENTIAL ACCOUNTABILITIES or TASKS:**

- Manages the Tampa Bay, Regional Field Office with a territory of 10-ten counties for Enterprise Florida.
- Through pro-active marketing and outreach efforts develop a clientele of export-ready manufacturing and other firms that are able to utilize EFI's export programs.
- Counsel targeted companies to upgrade their knowledge of export markets, export marketing and the export process.
- Strategize, promote and then recruit targeted companies to participate in ITD's market site trade event program.
- Provide market information, counseling and troubleshooting assistance to Florida companies, in order to generate export sales and to expose them to EFI trade leads.
- Promotes and encourages to targeted companies the utilization of federal export promotion programs, especially the US Department of Commerce.
- Pro-actively advocates Florida's international advantages and EFI services through participation in international conferences, seminars and workshops – through speeches, presentations and panel discussions.
- Implements selected strategic challenges industry trade fairs on a global scope. This requires overall event management that includes market planning, promotion, recruitment of manufacturers, trade results and coordination on a cost recovery basis.
- Act as community liaison and resource for business recruitment and retention and other related EFI departmental programs and activities, as warranted.
