

International Registration Grants

New Enterprise Florida pilot program provides trade grants to help Florida companies increase export sales through international product registrations and markings.

To help your company increase export sales and enter new markets overseas, we understand that having the right international registrations, certifications, or markings for your products is vital to your company's success in the global marketplace.

Through the state's Export Diversification and Expansion Initiative, Enterprise Florida has launched the pilot *International Registration Grants* program to help small to medium-sized manufacturers offset the costs of obtaining such registrations required to do business in foreign markets.

Companies with a significant international portfolio grow faster, are more profitable, and less susceptible to domestic downturns. Don't let the costs of compliance with standards in global markets keep your company from expanding overseas!

Other sectors will be considered upon request.

Qualified applicants will be reimbursed 50% of the international registration/certification application fee, up to a maximum of \$10,000.

International Registration Grants

Applying for an International Registration Grant

Qualified Florida small and medium-sized manufacturers from all regions of the state are eligible to participate in the program. Some of the requirements include:

- Companies must be located and registered to do business in the state of Florida.
- Must be in business for a minimum of two years.
- The product must be produced in the state.
- Must be a small business (employing 1-500 employees).
- International registrations/certifications must be held outside the United States, including commonwealths and territories.
- Eligible registrations/certifications include, but are not limited to:
 - CE Mark
 - ETL Listed Mark
 - ANVISA
 - Aircraft Airworthiness Licenses
 - Sanitary Certificates
 - COFIAS

Other registrations/certifications may be considered upon request.

 Companies may apply for one International Registration Grant per year, from July 1 to June 30.
